DECLARATION OF EMERGENCY CURFEW LIFTED

WHEREAS, on Tuesday June 2, 2020 Mayor Paul G. Davis lifted the curfew for the Town of Maxton beginning at 1:00 p.m. Town of Maxton, Robeson County.

WHEREAS, as a result of precautionary reasons following protesters throughout the country addressing the death of George Floyd.

WHEREAS, Mayor Davis is asking all citizens and business owners to observe that the curfew has been lifted and will be enforced by law enforcement for the safety of the general public.

NOW, THEREFORE, pursuant to the authority vested in me as the Mayor of the Town of Maxton under Division 2. Curfew 26-181.of the Town of Maxton Code of Ordinances:

This declaration was taken in effect on Tuesday June 2, 2020 and shall remain in effect until modified or rescinded.

Section 1. A State of Emergency is hereby has been lifted within the jurisdiction of The Town of Maxton.

Section 2. The emergency area covered by this state of emergency has been lifted shall be the Town of Maxton and the extraterritorial jurisdiction area (ETJ)

Section 3. The following restrictions and prohibitions has been lifted: Traveling upon any public street or roadway or upon any other public property, except by those in search of medical assistance, food or other commodities or services necessary to sustain the well-being of themselves or their families or some member thereof, or medical personnel, and their support staff, traveling to and from their respective places of practice, individuals assisting in caring for the sick or wounded, etc., other emergency related workers, or individuals helping with cleanup and restoration.

A. **Curfew**: The Town of Maxton has been lifted and went into effect on Tuesday June 2, 2020 at 1:00 p.m.

B. **Business Operations**: The business operation normal hours went into effect at 1:00 p.m. on Tuesday June 2, 2020.

Section 4. I hereby order all city law enforcement officers and employees and all other emergency management personnel subject to our control to cooperate in the enforcement and implementation of the provisions of this Declaration, all applicable local ordinances, state and federal laws, and the Town of Maxton Emergency Operations Plan.

Section 5. I hereby order this declaration: (a) to be distributed to the news media and other organizations calculated to bring its contents to the attention of the general public; (b) to be filed with Clerk to the Town of Maxton and (c) to be distributed to others as necessary to ensure proper implementation of this declaration.

Section 6. This declaration shall take effect on Tuesday June 2, 2020 at 1:00 **p.m.** and shall remain in effect until modified or rescinded.
