Mayor Davis request a motion to approve Consent Agenda. Commissioner McDowell made the motion and it was seconded by Commissioner Gilmore. The vote was unanimous and the motion carried.

He also mentioned the towns need for assistance with its water issues and advised contacting Mr. Jim Perry at the Lumber River Counsel of Government in Pembroke, N.C.

Mrs. Charnette Murphy, 412 McCaskill Street Maxton, 267-207-5431. Mrs. Murphy referenced the foliage covering the signs on HWY 71, by the by-pass that she brought to the towns attention a year ago. She said the same issue of the foliage almost caused her to get in an accident three weeks ago. She asked the Board of Commissioner if it would be possible to set up a question and answer session with the town residents in the future.

REPORTS

Police Chief:

Police Chief William Davis said the Town of Maxton Police Department is working with the Scotland County Sheriff's Office and Sheriff Percy. He is helping the town Police Department with a program to help them track the our elderly residents and their wellbeing. More information on the program is to come in the following week.

A six month old Belgium Lebaron was donated by Adam's Kennel to the Police Department named Delta.

The Police Department utilization of new body cameras will being in August 2022.

National Night Out will be August 2, 2022, at Beachum Park from 6p.m. to 9 p.m.

Town Manager:

Mr. Berdie Bullard rescinded an offer from the town to buy a parcel of land from him.

The town applied for funding through our State Representative Charles Graham that was not approved. It was recommended that the town apply for funding again to be included in next year's State Budget.

Commissioners:

Commissioner McDowell voiced that the town Board of Commissioner need to help the towns Housing Authority Board in some capacity as residents and board members are complaining about an unfair process. He called for a meeting with the town Housing Authority Board to inquire about the housing issues.

Mayor Davis returned to New Business item a) Purchase of two (2) Aerators for Wastewater Plant. The Town Attorney reviewed the state statutes regarding bidding and receiving bids for purchases and expenditures. He said there are threshold holds amounts and the town is within that. He said we could explore other option before we make the decision, but we need to consider the emergent nature of the purchase. He stated there is no minimum bid requirement.

Mayor Davis request a motion to purchase two Aerators for the Wastewater Plant costing \$53,446.24. Commissioner Womack made the motion and it was seconded by Commissioner McDowell. The vote was unanimous and the motion carried.
