Mayor Davis request a motion to approve Consent Agenda. Commissioner McDowell made the motion and it was seconded by Mayor Pro Tem Virgil Hutchinson. The vote was unanimous and the motion carried.

Mayor Davis request a motion to approve Budget Amendment for Withers Ravenal American ARP \$5,000.00 grant writing proposal. Commissioner McDowell made the motion and it was seconded by Commissioner Womack. The vote was unanimous and the motion carried.

Phillip Clark, 301 N. Florence Street Maxton, 912-658-8518. Mr. Clark spoke about himself and wife receiving a letter from the town that stated goats are a violation of the town ordinance within the town limits. He requested to know who reported him and a hearing to resolve the issue.

Robert Macy, 307 N. Florence Street Maxton, 910-844-1882. Mr. Macy following his statement of support of his neighbor's goats, gave the commissioners a list of why the Town of Maxton is not "A Good Place to Live," as its motto states. Mr. Macy said that Maxton is not a good place to live due to littering, the discharging of weapons, and speeding vehicles.

Gary Freeman, 308 N. Florence Street Maxton, 843-439-2135. Mr. Freeman following his statement of support for his neighbor's goats, said that you cannot use an ATM machine without being solicited by unwanted people and that speeding cars are a nuisance on Florence Street.

Mrs. Charnette Murphy, 412 McCaskill Street Maxton, 267-207-5431. Mrs. Murphy said the town's condition is horrific with its building falling down and with historical homes presenting hazards due to neglect. She ask if the owners of the dilapidated buildings were being cited and to wished to work with the town to get grants to better the town.

Anthony Raynor, 407 Croom Road Maxton, 631-320-9168. Mr. Raynor mentioned that he has lived in Maxton for three years, has had a gun pulled out on him on one occasion, and that there was a lack of transparency with the town's Police Department. Mr. Raynor mentioned problem with littering on Croom Road, incorrect tax information received from the administration, and about website security vulnerability to thief.

Phillip Clark, 301 N. Florence Street Maxton, 912-658-8518. Mr. Clark would like to know how the town is spending funds and that residents need additional information for transparency than receiving topics of the agenda.
