TOWN OF MAXTON BOARD OF COMMISSIONERS TOWN MEETING October 19, 2021 7:00 p.m. Minutes

The Board of Commissioners of Maxton, North Carolina met in formal session in the meeting chambers of the Town of Maxton Town Hall located at 201 McCaskill Avenue Maxton, North Carolina at 7:00 p.m.

In attendance were: Mayor Paul G. Davis, Mayor Pro Tem Virgil Hutchinson (absent), Commissioner Toni Bethea, Commissioner Elizabeth Gilmore, Commissioner Paul McDowell, and Commissioner Victor Womack.

Staff Present: Town Manager Angela Pitchford, Town Clerk Michael Cousar, Police Chief Na'Shayla Nelson, Public Works Director Preston McKenzie, Water and Wastewater Director Dennis Freeman.

Mayor Davis request a motion to approve the Consent Agenda. Commissioner Womack made the motion and it was seconded by Commissioner McDowell. The vote was unanimous and the motion carried.

Adopt the Proposed Agenda

Mayor Davis request a motion to adopt the Proposed Agenda. Commissioner McDowell made the motion and it was seconded by Commissioner Gilmore. The vote was unanimous and the motion carried.

OLD BUSINESS:

a) Resolution to Adopt Compliance Plans for CDBG-I (Infrastructure) Project.

Mayor Davis request a motion to adopt Compliance Plans for CDBG-I (Infrastructure) Project. Commissioner Gilmore made the motion and it was seconded by Commissioner McDowell. The vote was unanimous and the motion carried.

a) Dr. Leslie Sessoms - President of Ministers For Justice Organization in Robeson County.

Dr. Sessoms spoke about her organization (Ministers For Justice) and how they can and want to partner with the Town of Maxton to promote equity for all in the area. They are an ethnically diverse group of eight (8) ministers working together to promote unity and justice in Robeson community.

b) Approve Low Income Household Assistance Program (LIHWAP) Water and Wastewater Vendor Agreement.

Mayor Davis request a motion to approve Low Income Household Assistance Program (LIHWAP) Water and Wastewater Vendor Agreement. Commissioner McDowell made the motion and it was seconded by Commissioner Bethea. The vote was unanimous and the motion carried.

Mayor Davis request a motion to approve Safety First on Halloween Proclamation. Commissioner McDowell made the motion and it was seconded by Commissioner Bethea. The vote was unanimous and the motion carried.

Carol Bethea, 19 Martin Luther King Drive, Maxton, 910-414-2654. Ms. Bethea spoke of a shooting that occurred on September 12, 2021, and wanted to address it with the Maxton Chief of Police. She felt that she was treated unfairly in the shooting incident and mentioned another shoot after the first incident. She said she was receiving threats, did not feel safe, and just needs help with the matter.

Mrs. Diane Dixon, 402 North Patterson Street, Maxton, 910-217-5400. Mrs. Dixon spoke about how at the last town meeting she was hit with plaster falling from the chamber ceiling, the poor condition of the building within town, and how no one follows up on comments and questions presented during the Public Forum.

Ms. Debra Braddy, 64 Fence Road, Maxton, 910-390-9236. Ms. Braddy addressed the shooting incident on September 12, 2021. She stated that she called the police department on the day of the shooting for help and said they had no one to send to her aide and received the same response for the shooting that followed. She said the town needed more police officer to protect and serve the Town of Maxton.

Ms. Myra Love, 3185 NC Hwy 71, Maxton, 910-844-2265. Ms. Love spoke of the shooting incident that occurred on October 4, 2021, and the involvement of both parts. She feels her family is not safe and wants the police department to address the matter.

Mr. James McDougal, 383 Hwy 71, Maxton, 336-426-6966. Mr. McDougal said the towns' police response to crime is not there for the community and that it is more reactive than proactive. He mentioned

the street in front of his business as being like a drag strip. He said we, the police department, Board, and community must do something.

Mrs. Jamie Smith, (910) 785-2665, Maxton. Mrs. Smith spoke representing the Recreation Committee and community. She talked about concerns of not taking care of the Town of Maxton first as a non-profit organization was giving support and assistance that she feels was unfair. She mentioned the inabilities of the Recreation Committee to provide support to the youth and to work together with the Beautification Committee, and events held by the Recreation Committee for the month of September 2021.

Ms. Aggie Deese, 106 Smith Street, Maxton, 910-844-5946. Ms. Deese asked those in attendance to give a donation to the Town Recreation Committee.

Mrs. Mary McNeil, 407 West Central Street, Maxton, 910-217-9294. Mrs. McNeil said the Recreation Committee needs funding and support to help the community.

REPORTS

Police Chief:

Police Chief Na'Shayla Nelson deviated from her report to address the concerns presented in the Public Forum by town residents. Chief Nelson stated that there is an influx in calls for service, 400 more calls at this same time last year and with the same overall number of staffing (10). The Police Department has reached each out and currently are being assisted by the state police, Scotland County, Robeson County, and commissioners. She said arrest have been made in each of the shooting incidents and that the information has been released to the media. Chief Nelson said she is always available to the community.

Commissioner McDowell said the town is two (2) weeks away from the November 2, 2021, Municipal Election and that we have two seats open.

Commissioner Bethea mentioned that Christmas trees are on sale for \$75.00.

Mayor Davis said that Chief Nelson has been working diligently to organize the Community Watch Program and that no one from the community has assisted in the program. He told all in attendance that we must do our part to help out the community.
